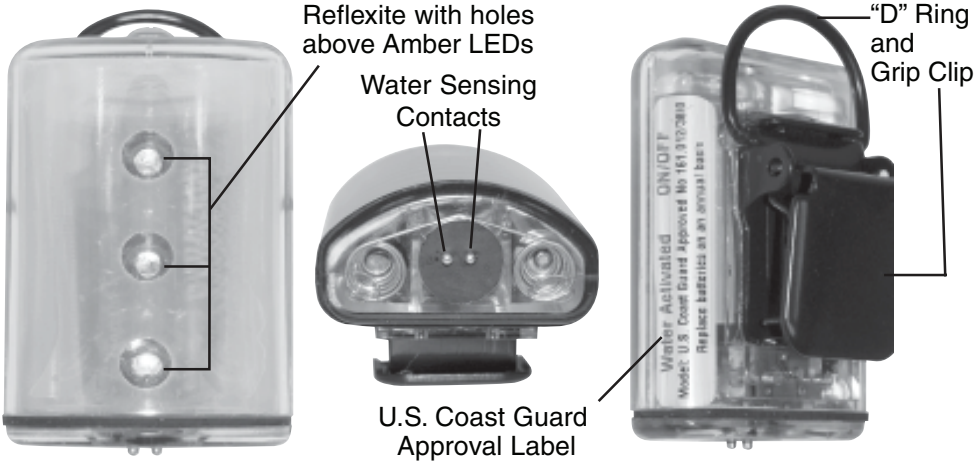

**Introduction**

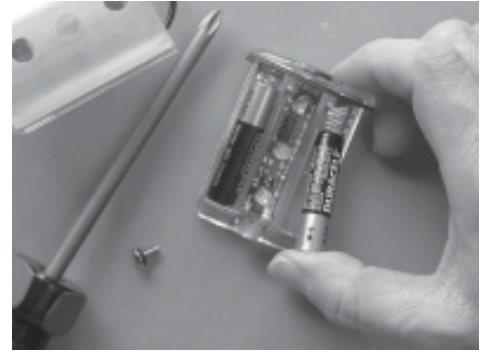

**Operating Instructions**

1. To activate Lite Tracker<sup>®</sup> immerse in water. Once contacts are wet, Lite Tracker<sup>®</sup> will start Flashing.
2. To deactivate Lite Tracker<sup>®</sup>, remove from water and dry off contacts. Unit will shut off in approximately 120 seconds.
